Indeed, I understand that I may be required to reimburse CMC for any funds received for the period of time in which I am no longer in country.

Having examined and understood the above, I (for myself, and my heirs, executors, administrators and assigns) hereby release, discharge, and waive any and all rights or claims for injuries or losses of any description arising in connection with any aspect of the Program or Experience, including but not limited to claims for damage to or loss of property, consequential damages, violation of civil rights, personal illness or injury, or death, that I may have to which may hereafter accrue to me against CMC and all of its current and former trustees, officers, employees or agents, and/or any sponsoring institutions.

I agree that if any portion of this Acknowledgment and Assumption of Risks and Release Agreement is deemed unenforceable, all other provisions will remain in full force and effect.

I understand and agree that no oral representations or statements by the College or its representatives will effectively alter the acknowledgments, agreements and representations stated above.
